RECORD OF PROCEEDINGS FOR THE
GOVERNING BODY OF THE
TOWN OF WHEATLAND

A special meeting of the Town Council of the Town of Wheatland, Platte County, State of Wyoming was held in the Council Room of the Town Hall at 7:30 P.M. for the purpose of a public hearing on the renewal of the liquor licenses.

Mayor Dingman opened the public hearing at 7:30 P.M. and requested a roll call. Councilman Wilson, Hensel, Geile and Wilhelm were present along with Town Clerk/Treasurer, Cindy Kahler, Town Attorney, Doug Weaver and Police Chief, Steve Gilmore.

Clerk/Treasurer, Cindy Kahler stated that the Wheatland Moose Lodge #1636 and the Wheatland Country Club are “club licenses”, El Gringo’s is a “restaurant license” and all of the others are “retail”.

Mayor Dingman asked if there were any comments or objections concerning any of the licenses presently up for renewal. Since there were no objections, Mayor Dingman stated the licenses would be approved individually by roll call vote.

A motion was made by Councilman Geile and seconded by Councilman Hensel to approve the renewal of the liquor license held by Wheatland Moose Lodge #1636. Voting yes- Councilmen Wilhelm, Geile and Hensel, Mayor Dingman, Voting no - Councilman Wilson. Motion carried 4-1

A motion was made by Councilman Wilhelm and seconded by Councilman Hensel to approve the renewal of the liquor license held by the Wheatland Country Club. Voting yes- Councilman Wilhelm, Geile and Hensel, Mayor Dingman Voting no-Councilman Wilson. Motion carried 4-1.

A motion was made by Councilman Hensel and seconded by Councilman Geile to approve the renewal of the liquor license held by Dusty Boots, Incorporated dba Vimbo’s Dusty Boots. Voting yes- Councilman Hensel, Wilhelm and Geile, Mayor Dingman Voting no - Councilman Wilson. Motion carried 4-1

A motion was made by Councilman Wilhelm and seconded by Councilman Hensel to approve the renewal of the liquor license held by Jimmy G. Wilson dba Wheatlanes Bowling Alley. Voting yes-Councilmen Geile, Hensel and Wilhelm, Mayor Dingman Voting no-Councilman

Wilson. Motion carried 4-1.

A motion was made by Councilman Hensel and seconded by Councilman Wilhelm to approve the renewal of the liquor license held by Lori & Cari Britton and Larry Fertig dba 49'er. Voting yes- Councilman Hensel, Geile and Wilhelm, Mayor Dingman Voting no-Councilman Wilson. Motion carried 4-1.

A motion was made by Councilman Geile and seconded by Councilman Wilhelm to approve the renewal of the liquor license held by Commodore Bar, Incorporated. Voting yes- Councilman Geile, Hensel and Wilhelm, Mayor Dingman Voting no - Councilman Wilson. Motion carried 4-1.

A motion was made by Councilman Wilhelm and seconded by Councilman Hensel to approve the renewal of the liquor license held by LeAnn's Incorporated. Voting yes-Councilman Wilhelm, Hensel and Geile, Mayor Dingman Voting no-Councilman Wilson Motion carried 4-1.

A motion was made by Councilman Hensel and seconded by Councilman Geile to approve the renewal of the liquor license held by Big A, Incorporated dba Big A Liquors, The Mine. Voting yes-Councilmen Hensel, Geile and Wilhelm, Mayor Dingman Voting no-Councilman Wilson. Motion carried 4-1.

A motion was made by Councilman Geile and seconded by Councilman Wilhelm to approve the renewal of the liquor license held by Harvey Cozad dba Landmark Bar. Voting yes- Councilmen Geile, Wilhelm and Hensel, Mayor Dingman Voting no - Councilman Wilson Motion carried 4-1.

A motion was made by Councilman Wilhelm and seconded by Councilman Hensel to approve the renewal of the liquor license held by Casey Laffitte dba Casey's Timberhaus. Voting yes-Councilmen Wilhelm, Geile and Hensel, Mayor Dingman Voting no-Councilman Wilson Motion carried 4-1.

A motion was made by Councilman Hensel and seconded by Councilman Geile to approve the renewal of the liquor license held by Jin H, Min dba El Gringo's. Voting yes- Councilmen Geile, Hensel and Wilhelm, Mayor Dingman Voting no - Councilman Wilson. Motion carried 4-1.

With no further business to come before the Governing Body, Mayor Dingman adjourned the meeting at 7:40 P.M..
