Ed died Wednesday, Sept. 14, at his home in Wheatland, surrounded by loving family and friends.

Andrew Edward "Ed" Kendig was born June 28, 1925, in Burns and was the first baby born in the town's new

hospital. He was son of Andrew LeRoy and Bess (Horton) Kendig.

The family moved to Cheyenne in 1938 and later to Wheatland where Ed graduated from Wheatland High School in1943. He attended one semester at Colorado University at Boulder before joining the United States Army. He served in World War II as a Sft. First Class with the 506th M.P. Battalion, serving two-and-a-half year,s including nine months in Europe. Upon his discharge, he returned to Colorado University majoring in Business and graduating in 1949; and then Harvard School of Law, graduating in 1952.

After law school, he returned to Wheatland in 1952 to be admitted to the practice of law and join his father in State Bank of Wheatland. In 1954, he moved to Denver, Colo., passed the Colorado Bar examination, and worked briefly for the law firm of Pershing, Bosworth, Dick & Dawson. However, the call of home and Wyoming brought him back to Wheatland to join his father again in State Bank

of Wheatland, later known as First National Bank in Wheatland (the largest and most financially secure bank in Platte County), and still later Norwest Bank-Wyoming, from which he retired as president in 1987.

His life was primarily devoted to banking; but, he also served as State Senator of Wyoming from 1963-1977. On Aug. 28, 1976, he married Sandra Robb Outsen in Cheyenne.

Mr. Kendig was past President of the Wyoming Banker's Association, school board Trustee in Wheatland 1958-1967; and a past Director of the

Independent Banker's Association. He was a member of the Wheatland Lions Club, All Saints' Episcopal Church, and Veterans of Foreign Wars Post No. 3558.

Survivors include his "caregiver family", Chuck Shellhart, Lynn Phelps, Louise Shepard, Shirley Keil, Gloria Skager, Richard Bohm, and Cindy Schilreff; several cousins and many dear friends.

He was preceded in death by his parents and wife, Sandy on Dec. 28, 1993.
